## Report on the EAPC Web Site - www.eapcnet.org General Assembly 1 April 2001, Palermo 7<sup>th</sup> Congress of the EAPC

The EAPC web site was launched in June 1999.

#### **Objectives**

- To support the aims of the EAPC by increasing awareness and promoting the development of palliative care
- To provide updated information as quickly as possible to our members
- To include all current and future activities of the EAPC.

Two years after its launch, the site is now being redesigned, reorganised and restructured for a second time - to take advantage of the latest advances in technology and also because of the following:

- 1. The dynamic development of the EAPC and its activities
- 2. The adaptation of a structure more suitable to the advancement of the Association
- 3. The creation of a more complex communication policy, which also includes the *European Journal for Palliative Care* (EJPC) and the Congress web sites.

Our official journal, the *EJPC* is published six times a year in English and French simultaneously. The EJPC also has its own web site to which our site is linked. This site not only contains information on current issues covered by the journal, but also information on back issues and lists of articles that have been published. Online feedback allows to comment on any articles and features in the journal. Full details of the site are found in every issue of the journal.

Our experience over the last few years shows that a web site for an association of our kind, especially working on an international basis, requires regular updates. This demands a technology that allows easy and quick updates, which can be carried out by staff who are not IT professionals.

An association's web site should not only report the activities of the Association, but it should be a reference point from which you can access detailed information about palliative care all over the world. Therefore, we will structure the updated version our web site into three main parts:

#### The first part is linked to the institutional information about the Association

- By-1aws - Assemblies

Membership (how to join)

- Individual members (English),

- Membres individuels (Français)

National associations - 'collective' membership (English)
Associations nationales - membres 'collectives' (Français)

- EAPC membership yesterday and today

## What are the challenges for the future?

- 1. Completing the directory about laws and documents of official (governmental) bodies
- 2. Making the site interactive to permit communication with members directly onsite.
  - Discussion forums following EAPC Congresses
  - Moderated discussion forums on burning topics
  - Chat
  - Online help service for professionals.....
- 3. Encouraging members and National Associations to use the site to learn about and profit from what happens in Europe
- 4. Getting the members and National Associations to *regularly* forward national and local information they consider important to be brought to the knowledge of all their colleagues.
- 5. Including an information service about what happens at the European Community, the European Council, and the European Parliament regarding palliative care.
