35th Expert Committee on Drug Dependence

The 35th Expert Committee on Drug Dependence will meet from 20 – 23 April 2009. The proposed <u>agenda</u> is available on the web.

WHO Guidelines on Treatment of Pain

WHO is working on a series of guidelines that cover treatment of all types of pain. The guidelines will include an update of the guidelines 'Cancer Pain Relief (2nd Ed.)' which is now over 10 years old and 'Cancer Pain Relief in Children'. The first steps have been initiated in the development of guidelines on chronic pain in adults and in children. As soon as resources allow, the guidelines on acute pain will follow. The project is part of the Access to Controlled Medications Programme and is being carried out by a number of WHO Departments in cooperation with the International Association for the Study of Pain, the European Association for Palliative Care and a number of experts from all around the world.

It is expected that the first guidelines will be published in 2010.

Manufacturers Database

WHO's Department of HIV/AIDS, Unit of AIDS Medicines and Diagnostics Services, has developed the WHO Controlled Substances Database with manufacturers of methadone, buprenorphine and morphine.
